Other Site Characteristics

Area collinare formata di rocce calcaree che culmina nel Monte Nero (m 659) e solcata da valloni; la zona è completamente ricoperta da boschi cedui di sclerofille sempreverdi (leccete) e di caducifoglie, tra cui la roverella e il faggio, qui sviluppato a quote molto basse (m 350). L'habitat 6210 è da considerarsi prioritario.

4.2 Quality and importance

L'interesse della Macchia di Montenero è prevalentemente fitogeografico ed è dovuto alla presenza di lembi di vegetazione mediterranea, accanto a formazioni submediterranee di roverella e a boschi di faggio ad impronta montana. Stato di conservazione buono.
