Trattasi di due bacini con fondo pianeggiante, situati nell'Appennino Marchigiano alle quote di m 885 e 924 rispettivamente, di origine tettonica e interessati da fenomeni di carsimo, come si può notare dalla presenza di alcuni inghiottitoi; il piano inferiore nei mesi autunnali e invernali ospita un lago temporaneo. La vegetazione, formata di prati umidi, inondati e palustri, è disposta in fasce concentriche, in relazione alle caratteristiche geomorfologiche e al regime idrico.Ranunculion Velutini: 10% ; Caricion gracilis: 60%
