Gruppo montuoso formato di arenarie, localizzato a oriente dei Monti Sibillini, dai quali è separato da Colle Galluccio; esso culmina con il Monte Ceresa (m 1494); la zona è quasi completamente ricoperta da boschi di faggio, anche con presenza di agrifoglio, interrotti da radure con prati falciabili.

4.2 Quality and importance

Area di grande interesse per la presenza di un vasto complesso forestale, completamente sviluppato su substrato arenaceo; lo stato di conservazione dell'area in questione è buono, anche se i boschi sono prevalentemente allo stato di ceduo, peraltro con grande possibilità di recupero.
