Valico appenninico situato a m 1197, al limite orientale della catena dei Monti Sibillini, con vegetazione prativa, alcune sorgenti, piccoli lembi di vegetazione torboso-palustre ed alcune macchie di faggete e pioppete a pioppo tremulo; la flora dei prati e delle piccole aree torboso-palustri è molto ricca e comprende anche specie rare in tutto l'Appennino.

4.2 Quality and importance

Area ancora ben conservata e caratterizzata dal paesaggio dei prati interrotti dalle macchie a nocciolo e pioppo tremulo, formatesi a seguito dell'abbandono della fienagione, di notevole interesse per la vegetazione prativa, che presenta aspetti da xerofili a meso-igrofil.
